county needs poll workers. They will have to fill out an applications now per Allison Grimes Sec of State. E Poll books was delivered to the clerks office. Election Machines will be tested tomorrow. The election ballots have been delivered also. New election machines are needed in the next 3-4 years due to age and repair options due to age.

Fiscal Court Report: Jerry Moody said the magistrates voted down a tax increase twice. They would rather cut cost and wasteful spending. A used van was purchased to transport prisoners. They are also looking into used police vehicles. The road department is in need of another tractor and they are looking at used tractors. A road department equipment auction will be held on April 20th. Looking into the legal way to sell the military vehicles the county owns.
