BOE Report: County Clerk Lynn Hesselbrock handed out latest update on the number of registered voters in party for Spencer County as of June 17, 2019. She is working on the improvement of the old fire department to accommodate the electronic voting equipment. There is a drainage tile problem that needs to be repaired there. A camera has been added to view the back alley for security. The County Clerks Association is working with Frankfort to adapt the rule about poll workers who change their parties have to set out one year before they can work at the polls again. They are also reviewing other parties being able to work at the election. Also looking to get a purchase price on new election equipment on a state wide bid. The county receives 34 cents per voter from the state. Clerks are trying to get the dead people removed from the voter rolls.

Fiscal Court Report: Magistrate Tim Brewer stated the sheriff's department was approved for a grant to purchase 25 new guns. The radio replacement has not been approved yet and the bid process is still on going after one bid for 27,000.00, Camera was approved for the election

equipment building for security. The county took over Elk Chase subdivision road due to the condition of the road. Watkins Glenn subdivision also is in bad shape but the owner of the

subdivision, Bobby Smith, said he would take care of the problem. The recycling center got a grant for 62,000.00 but was voted down at first but accepted on second vote. It will be used to buy cardboard balers. The 109 Committee wants county wide recycling if possible. They have not voted on pay raises yet without more study of who and how much is put on paper. It was mentioned if the county could trade in the radios we have or use them in another department. Waterloop Road had a washout and the resident rented equipment to fix it himself. Not a good showing for our county. Asking for Emergency funds to repair bridges damaged in our latest weather issues. Plum Ridge Road will stay open. The Animal Shelter is taking roof bids and a question was asked of Tim about the winning bid being put in after deadline. The bid process needs to be streamed line and equal across the board for all who bid. Same materials, design, deadline.
