Also improving and adding security to the building with the voting machine and supplies. Todd Birch is doing a great job with the road department. Spencer County got 414000.00 in money to blacktop parts of Spencer County. They are also taking bids on the repair of Hostrasser bridge that got damaged during the flash floods in the county.

The county employees got up to a .50 cent raise while positions that require being certified received more than a .50 cent raise. Also working on the drainage problems at the nursing home and feta reimburse projects.

**Legislative Report:** Rep. James Allen Tipton Special session called on July 19th for 5 day to pass HB1 Pension Relief Bill. Some bills are already being pre filed and others for the budget session of 2020. Year's end found that state was 200 million dollars above budget for 2019. In the hazard pension fund, the state added 60 million dollars at 12.9%. Red Flag laws have been on the lips of some legislators.
